3. Regulations Regarding the Evaluation

Candidates must strictly comply with the following regulations:

- **3.1 Dress Code:** Candidates must be dressed politely and appropriately according to custom, as follows:
 - o **Female Candidates:** Wear a collared shirt, polite-style skirt, and closed-toe or slingback shoes.
 - Male Candidates: Wear a collared shirt, polite-style trousers, tuck the shirt into the trousers, and wear closed-toe shoes.

/ Prohibited Items:

o **Prohibited Items:** Uncollared T-shirts, sleeveless shirts, or tank tops, shorts, jeans or denim skirts, and sandals are strictly forbidden, unless there is an appropriate and necessary reason and permission has been granted by the committee or invigilating officer.

3.2 It is the candidate's duty to know the date, time, venue, and examination room, and must enter the examination room strictly according to the specified date, time, and venue.

3.3 Candidates must strictly obey and follow the orders and instructions of the committee or invigilating officer throughout the examination period.

3.4 If any candidate fails to comply with these regulations and procedures, or commits or attempts to commit fraud in the examination, the committee or invigilating officer will immediately terminate that candidate's examination, and the University will consider withholding the scores for that individual.
