3. Teaching methods

Eligible candidates are required to prepare a lesson plan on one primary school subject in their area of expertise. The teaching demonstration will last no more than 10-15 minutes. Candidates must also prepare teaching materials such as PowerPoint, Canva, or other platforms to support their demonstration.

4. Examination Regulations

Applicants must strictly adhere to the following regulations:

4.1 Candidates must be dressed respectfully and appropriately according to traditional customs, as follows:

Ladies: Wear a collared shirt, a modest skirt, and closed-toe or slingback shoes.

Gentlemen: Wear a collared shirt, smart trousers, tuck the shirt into the trousers, and wear closed-toe shoes.

Wearing collarless t-shirts, sleeveless shirts, tank tops, shorts, jeans, denim skirts, or sandals is prohibited, unless there is a justifiable reason and permission has been granted by the examiner or invigilator.

4.2 It is the responsibility of the candidate to know the date, time, location of the examination, and examination room, and to attend the examination room only on the date, time, and location specified.

4.3 Candidates must strictly obey and follow the instructions and advice of the examiners or invigilators throughout the examination period.

4.4 If any candidate fails to comply with these examination rules and procedures, or commits fraud, or attempts to commit fraud during the examination, the examiner or invigilator will immediately terminate the examination for that candidate, and the university will consider withholding the grading for that individual.
